- An **entry fee of \$10** is required to participate. Payment must be made in store on the day of the competition.
- Participants will be given **6 sushi rolls** (options: karaage chicken or tempura vegetables) to consume using **CHOPSTICKS ONLY**. Using hands to pick up the sushi rolls will result in disqualification.
- Before the timer starts, participants must place both hands flat on the table and yell "miso hungry." The timer will stop once all sushi rolls have been swallowed completely and the participant yells "miso full."
- Participants can surrender by yelling "miso full"

- There will be **three winners** with the top winner being the participant who consumes the sushi rolls the **fastest**. In the event of a tie, a sudden-death round may be held.
- Water will be provided to all participants
- Participants are limited to ONE ATTEMPT ONLY
- Winners will be contacted after the event via email or phone call and may collect
  their prize on the day or on a more suitable later date. Failure to respond within
  48hours or failure to collect the prize on the organised date will result in the prize
  being passed onto the next participant on the leaderboard.
